Please note the following:

1.0 The manufacturer should have valid Selling licence for the State for which the party has quoted rates / intending to sell the material (as applicable)

2.0 The Registration of manufacturers of **Phosphate-rich Organic Manure (PROM)** will be made at RCF Ltd corporate office.

After Registration, the price to be quoted by manufacturer will be inclusive of following:

- a) FOR in a respective State.
- b) RCF margin **8% of Purchase Price (Base Price); excluding GST, Dealer Margin and other terms as per mutual agreement**
- c) Design/Artwork of package will be given by RCF Ltd, however relevant packaging to be supplied by manufacturer at own cost.

3.0 After registration, the manufacturer will have to submit "O" form and all required documents for Registration and inclusion in RCF Ltd Selling Licence in the respective State.

4.0 RCF Ltd will make payment to manufacturer after deducting RCF Ltd margin, dealer margin from MRP. The MRP is to be printed on package.

5.0 GM (M) / ED (M) of RCF will approve the price quoted by the manufacturer on FOR basis for packaged quantity of **Phosphate-rich Organic Manure (PROM)** delivered at dealers' place in the respective Area/State.

6.0 Manufacturer will be wholly responsible for the quality or quality related issue/matter of the material as per FCO specifications.

7.0 The manufacturer will enter in to an Agreement/MoU on Rs. 500 Stamp paper.

8.0 Consignment-wise /invoices with LR copies with seal and sign of recipient dealer are required for making payments.

9.0 All manufacturers will be at par for RCF fixed margin **8% of Purchase Price (Base Price); excluding GST, Dealer Margin and other terms as per mutual agreement**

10.0 Retention amount of 5% from running bills for each state in which material is supplied from running bills will be taken by RCF for ensuring quality as per FCO even at field level. This amount will be paid at the end of contract based on certificate that no sample of supplied quantity has failed till date. However, the amount will be withheld only for the quality found to be non-FCO and balance amount will be refunded to the supplier.

Please note: Registration is open for a period of one month from the date of publication of advertisement and the registration will be valid for three years, from the date of approval.
